- I acknowledge that the Pickering Horse Centre has a weight limit of 220lbs.
- LESSONS ARE NON TRANSFERABLE AND NON REFUNDABLE. In the event that a lesson is cancelled by Pickering Horse Centre Ltd., a make-up lesson or adjustment will be made. **Only two planned absences are permitted for every three month period. Minimum one week notice must be given (in writing) to receive a makeup. No makeup lessons will be given to those who have left the program.**
- Registrations are renewable monthly
- Pickering Horse Centre accepts cheques, e-transfers or credit card as payments.
- If paying by cheque we require a minimum of three months, post-dated for the 20th day of each month. **Any late payments made after the 20th of the month must pay an additional \$10.00 on top of the lesson fee.**
- If paying by credit card we require a pre-authorized form filled out and handed in with registration.
- If post-dated cheques/preauthorized credit card form are not remitted, then payments will be due on the 15th of the month prior.
- Fees: Group lessons (four lessons): \$295.00 + HST. Private lessons (four lessons): \$340 + HST
- Acceptable footwear, long pants and approved riding helmets are required to gain admittance to the lesson.
- Students that arrive after the lesson has left the barn are not permitted in the lesson.
- No students are allowed in unauthorized areas. Further, only the students are allowed in the stalls and in the barns.
- SMOKING IS NOT ALLOWED ON THE PROPERTY.
- Pickering Horse Centre Ltd. has the right to cancel and reschedule lessons due to extreme weather. It is the student's responsibility to confirm their scheduled lesson in extreme weather.
- A \$50.00 fee will be charged for all cheques that are returned from the bank for any reason.
- There is absolutely no coaching or interrupting allowed outside of the ring.
